BY-LAWS OF THE GREATER BUCKEYE LAKE
CHAMBER OF COMMERCE, INC.

ARTICLE 1

The name and style of this organization shall be “The Greater Buckeye Lake Chamber of Commerce Inc., a non-profit organization, with it’s principle place of business at P.O. Box 5, Buckeye Lake, Ohio 43008.

ARTICLE 2

Mission: To stimulate area business by sharing ideas, information and supporting our communities as well as educating the public on services and products our members provide.

Vision: To create and support a thriving business environment that provides a variety of services. This environment includes retail, coordinating seminars and events, maintaining a website that contains business-critical information.

Purpose: To strengthen area businesses through education and fellowship.

ARTICLE 3

The organization is to promote and secure the support of all businesses and professional persons and residents in and around the Buckeye Lake area through yearly membership. The Buckeye Lake area is defined as a 10 mile radius from any point on the shoreline of Buckeye Lake which includes communities in Fairfield, Licking and Perry counties.

ARTICLE 4

There shall be four types of membership as follows:

Business and Professional Members dues: \$50.00.

*Outside Area Business and Professional Members dues: \$75.00.

Associate Members dues: \$20.00.

*Outside Area Associate Members dues: \$30.00.

*Outside Area is defined as being outside of Fairfield, Licking and Perry Counties

Business Members shall be those persons engaged in any business or professional activity. Associate Members shall be those persons interested in the betterment of the Buckeye Lake area but, who are not directly engaged in any business or professional activity.

Dues paid after October 1st will be applied to the next membership year only. However, those new members paying after October 1st will be assured of all rights under our by-laws for the remainder of the year in which they paid their dues.

All members shall have equal voting rights.

ARTICLE 5

Officers shall be as follows: President, Vice-President, Secretary, Treasurer, and Three Trustees, one to be selected as chairperson by the Trustees.

ARTICLE 6

The Trustees, being the Executive Committee shall have the executive power to act in any emergency. The Trustees shall have the responsibility for the operation and management of the real properties owned by the organization. The Trustees shall assist the other officers in long-range financial planning and growth.

The duties of the President shall be to preside at all meetings of the Chamber of Commerce and shall perform all duties usually pertaining to the office.

The Vice-President shall act as an aide to the President and perform duties of the President in the absence of that officer. The Vice-President shall also succeed the President if that office should become vacant.

The Secretary shall keep records of all meetings of the organization and also give report of same

at the next consecutive meeting and will keep a complete list of names, addresses and telephone numbers of all members.

The Treasurer shall accept dues after being processed by the Secretary and shall keep record of all expenditures and receipts and maintain the Chamber of Commerce's checking accounts. A financial report shall be given at each regular meeting. The Treasurer shall pay all bills submitted to the organization, after approval by the President.

ARTICLE 7

The term of office of Trustees shall be three years, one to be elected each year.

The other Officers of the Chamber of Commerce shall be elected each year. Candidates for offices shall be presented by a nominating committee, which will consist of five persons selected by the President from both types of memberships. One candidate will be presented for each office. Candidates may also be nominated from the floor. The slate of candidates shall be presented by the nominating committee at the November meeting. The election shall be at the December meeting and shall be by secret ballot. Election shall be by a majority vote of eligible members present. To be eligible to vote for officers, a person must have been a member for 30 days prior to the election as certified by the Secretary.

ARTICLE 8

Standing Committees shall be as follows:

- Ways and means Committee
- Membership Committee
- Advertising and Publicity Committee

The Chairperson of each committee shall be appointed by the President. The Chairperson in turn shall select two or more members to serve on the committee. Every effort should be made to avoid having one member serve more than one committee.

ARTICLE 9

The Ways and means Committee shall be responsible for raising funds aside from membership dues. This money will be used in carrying out the functions of the organization.

ARTICLE 10

The Membership Committee shall develop methods for increasing the Chamber's membership and shall conduct membership drives and projects to further such drives.

ARTICLE 11

The Publicity Committee shall prepare a program through newspapers, radio, television or other publications of the Chamber's activities and capitalize on any and all news items, improvements and developments at Buckeye Lake.

ARTICLE 12

The By-Laws of the Chamber of Commerce may be amended by a two-thirds majority vote of members present providing, such amendment has been presented in writing and signed by ten eligible members and read at the previous regular meeting.

ARTICLE 13

Regular meetings shall be held monthly. Members shall be notified of the time and location of each meeting by a committee under the supervision of the Secretary.

ARTICLE 14

No salaries or fees shall be paid to any member or officer of the Chamber of Commerce except the Secretary who will be paid \$1200.00 a year, (\$600.00 in June and \$600.00 In December) and in the event an officer is hired by the Trustees.
